## **6 Business Arising from the Minutes**

#### 6.1 New Governing Documents Reading

- Bylaw 1
  - General meetings and new Board of Directors.
  - BoD hasn't been picked yet, to be elections at the next meeting.
  - Did not recommending incorporating, though we got our documents ready for that if we choose to in the future.
  - Three general meetings to be held per year
  - Petitions signed by 50 students can be used to call for meetings/added to meetings
  - 14 day limit for adding items to the agenda, no adding items at the meeting
  - Special meetings (by petition) still need 14 days notice
  - Only one proxy per person
  - Exec section of documents remains basically the same
  - At BoD meetings, each director has one vote, each meeting can only be attended by board members or people they invite, though meeting minutes will be made public
  - 4 A soc and 4 B soc members on BoD
- Elections and Referendum

- CRO cannot run for office
- BoD elected at Joint General meeting
- Timeline for elections made more clear

- Must present finance statements to any member who asks to see them
- Now lists some of EngSoc's other bank accounts for those who are interested

#### 6.2 E7 Update

- 70% quiet study space, 30% group space in E7 for students
- No computer lab computers, "bring your own device" space
- Space managed by EngSoc
- Q: Why is there a group study area in the quiet study space?
   A: There will be quiet group space, just not too much
   Response: Don't we already have a space like that in DC?
   Response: This would be an engineering specific space.
- Those who have different opinions on what the space should be like should contact David who will discuss the space with Dean Sullivan
- Q: Could we have standing desks instead of sitting desks?
   A: It would be possible to add some standing desks.
- Q: Where are the stairs?A: Not into this room, the entrance is through glass doors.
- There will be a POETS like room where students can hold events
- Q: How large are the lecture halls going to be?
   A: The ECE ones will fit 140, the MME ones will fit 132.

- Q: Will there be space for Eviro/Geo/Civil?
   A: No, becasue they just got new space in DWE. EngSoc doesn't have a say in where the departments have space.
- Q: Will the lecture halls have good outlets?
   A: Yes, as well as WIFI, but no wired internet.
- Q: When will the building close at night?
   A: It's hoped the study space will be open 24 hours, except for cleaning but that is for EngSoc to decide
- Other suggestions:
  - Bookable, small, skype/conversation type room
  - A couple gender-neutral washrooms
  - Standing desks in the study space
  - Stairs not like the E5 ones
  - USB ports for power
